The following is available to you for your information, and is provided in an effort to assist you in your decision-making process. The goods and services shown below are those we can provide to families. You may choose only the items you desire. Any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements dictate that you must buy any items that you did not specifically ask for, we will explain the reason in writing on the statement that we provide describing the funeral goods and services you selected (Funeral Service Purchase Agreement).

Funeral Home Services

This list does not include prices for certain items that you might ask us to buy for you, such as cemetery or crematory services, flowers, death certificates, or newspaper notices. The price for these items will be shown on your statement and on the Funeral Service Purchase Agreement.

Professional Services and Facilities

This portion of our charges indicates and includes the cost of providing all of the requested and essential services on a 24-hour day basis. The cost of the salaries, benefits (including health-care), training and educational expenses of the funeral directors and all other staff is distributed proportionately over these charges. Also included is the per-funeral share of our maintenance, insurance, taxes, utilities and communication expenses, and repairs.

Funeral Director and Staff (Basic Services)

This basic service charge includes but is not limited to the Professional Licensing of our funeral directors, consultation with the family and clergy, arrangement of funeral desired, preparation and filing of necessary notices, authorizations and consents, attendance prior to, during and following the funeral, and coordinating with those providing other portions of the funeral; e.g. clergy, cemeteries, crematories and others as required.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains to or from a different city or town.

The *Basic Services* fee also includes any or all of the following: washing/cleansing, topical disinfection, clothing of remains, adjustments (Receiving remains from another location), cosmetizing, casketing of remains.

Preparation/Embalming

\$785

Except in certain special cases embalming is not required by law. Embalming may be necessary; however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Green Funerals

(A descriptive brochure is available at the funeral home) - This establishment is one of a select number of funeral homes who meet the criteria for providing green funeral services set by the Green Burial Council; a tax-exempt, nonprofit organization working to encourage environmental sustainability in the field of funeral service. These offerings allow for a funeral to take place without the use of toxic or non-biodegradable materials/chemicals. Caskets and shrouds are made available to enclose and transport the deceased. Body preparation, provided by this funeral home and suitable for a green funeral service, consists of either refrigeration, the use of topical sprays/compounds, or arterial embalming with essential oils. Home or public visitations, church funerals and graveside services are options that may be arranged within the time frame that a green funeral allows. Please see our supplemental price list for detailed information regarding our service and merchandise offerings.

Any funeral can include varying degrees of eco-friendly elements. A selection of garments, caskets, urns, and practices are available at the funeral home. The prices specific to Green funerals are the same as those of standard funeral practices with the exception of the preparation/embalming procedure. Because the fluid used in the preparation of the remains is highly specialized (formalin-free), the charge for the embalming process is \$865.

- If unpaid for any reason, interest at the rate of 1% per month (12% annually) will be added to the total due, or unpaid portion thereof.
- We will accept paid-up, in-force life insurance policies as payment of the total or partial cost of the funeral with a down-payment equal to the amount of section **C. Items Advanced by Funeral Home**.
- **ESTATES** are not acceptable as a form of payment.
